We continue with our focus on education of girls; we celebrated National Girl Child Day, to sensitize people about the importance of educating and protecting girls. RASTA is actively engaged in uplifting the educationally and socially backward. We have, therefore, selected our project locations thickly populated by Muslims.

Education a Gateway to Development

The people struggling to make their both ends meet never considered education as important before. The incidences of non-enrollment and dropping out at primary level were very frequent. Education for girls was not given any serious consideration because of cultural reasons.

The organization gave holistic consideration to education in which education becomes accessible to all categories and all age groups.

Pre-school education prepared the children for formal schooling. Non formal education facilitated education for the drop outs and out of school children. Remedial education helped the school-going students to cope with the teaching in the school. Adult education and distance education covered the left out adults. Highlights in the Education Sector are the collaborations with the Pradhamik Vidyalaya, Sudamapuri, Ghaziabad and Mobile Creches in Gurgaon (HR).

The formal schools were also linked for the improvement of their teaching methodology. Open schooling system was used for the working children. Celebrations and frequent meetings made the programme a community event.

The main features of education were the low cost teaching learning material and participatory learning process in which learning became a joyful activity. Children and their parents became active stakeholders in the process of learning. Rasta interacted with more than 5691 people including children and their parents in this endeavour.

Shabeena dreams big now!

Shabeena lives in very small rented room at Khora with her three sisters, mother and grandmother. She is the second of her mother's four daughters. Her father had abandoned the family long ego, cursing her mother for giving birth to only girls. Shabena's mother and grandmother struggled to bring up the children and run the family. Rasta came in touch with the family in 2011 when Shabeena was 10 years old and not yet going to school. On Rasta staff 's motivation and persuasion, her mother enrolled Shabeena in Rasta School and now she is in Class IV. Her elder sister, Kaushar after Primary education, discontinued schooling and started working to support the family. Other two sisters also have been enrolled in Rasta School.

Shabeena dreams big and wants to become a doctor. "When I become a doctor, says Shabeena, our father will feel proud and come back".

Siraj with his wife and 7 children migrated from Uttar Pradesh to Delhi in search of livelihood and was lucky to get work as construction labourers. This, however, is a hard life involving movement from place to place, leading to neglect of children's studies and care. Thanks to Mobile Creche, Rasta set up a Day Care Centre at Palm drive, close to the construction site. Rasta helped the family to make their Adhar Card which would stand them in good stead to prove their identity and claim their entitlements.

Rasta persuaded the eldest daughter Aarushi to remain at the Centre, enrolled the next three children, 10, 8, and 6 years old, respectively in III, II and I standards of the nearby Government School, and took care of the other three siblings at the Day Care Centre, where they get the much needed protection, nutritional food three times and health care in a joyful atmosphere with other similar children.

Learning to Earning

A skilled person is a permanent source of income for the family and commands respect in the family and the community. The available sources of vocational skill training in the nearby areas are too expensive for the families to avail of. Access to the available sources is also another serious problem for women.

The girls and women were imparted inputs to develop their behavioral aspect to interact with people with confidence. The youth were provided skill training in trades like 'English for Employability', 'Spoken English', 'Retail Management', Personality Development', 'Basic Management', 'Computer', 'Tailoring', Beauty Culture' etc. Rasta's Vocational Training Sector continues to be a boon to several to supplement the income of their families.

They were given training at par with the best available in the area. The skills acquired enabled them to set up their own units and also find employment in the nearby pockets of the community. The technical skills of these girls was further enriched with marketing and managerial skills as well.

The girls who were confined within the four walls of their houses are now confident earners for their families. They are more confident in other walks of their lives as well. Other family members have more respect for them.

Jitendri has taken admission in STEP Course. Parents want to educate only Jitendri because she is good in studies. Kamlesh didn't get the chance for higher education. Her father is an Asthma Patient and is unable to do anything. Kamlesh's mother, who sells vegetables in streets, is the only earning member. Through Jitendri Rasta Team came to know about Kamlesh's interest in this course. Rasta Team visited her home and motivated her parents to enroll Kamlesh for the vocational training program of Computer Skills, English and Management. She joined the course. After successful completion of the course, Kamlesh has shown remarkable self-confidence. She is hopeful of securing a good job and says "My mother will no longer have to sell vegetables".

Samreen belongs to a Muslim family where women are to the four walls of the house and remains often behind Samreen's husband divorced her three years after marr then she lived with her parents at Khureji Khas. She was b the household chores, wass unskilled and couldn't sec gainful employment. Being too much economically deper her parents was an unfavourable situation and she had beer her brains on how to change it. It was at this time that R during one of their community visits, came in touch v From them Samreen came to know about the vocational programmes conducted by Rasta and she wanted to und Beauty Parlour Training. But her parents were against i being a divorcee was a stigma and would invite unf comments when she went about for training and then Rasta's Community Workers visited the parents a fev dialogued with them and ultimately made them agree to undergoing the Beauty Parlour Training. Samreen compl Training successfully. Today she is a beauty Parlour Inst Bridge Puri, Khureji Khas, at a monthly salary of Rs 10,000

Sound Body Sound Mind

Rasta's Community Health Programme imparted preventive and promotive and curative health awareness and care to over **59844** people of all age groups in 2014-15. Lack of awareness was considered a big blockage. Awareness was imparted through street plays and individual interactions.

Meetings were held for advocacy services both with community people and the concerned government departments. Health camps were organized to remove ignorance of the people.

Identification of HIV/AIDS and treatment were done at wider level because of big number of migrant population. Counseling services and treatment were facilitated.

Preventive health services were started for healthy childhood. Growth monitoring was done to educate the mothers on child development and related steps. Immunization, pulse polio drops, nutrition services, etc., were adequately planned and imparted with the help of prominent institution like AIIMS and Max India foundation through medically trained staff.

Special attention was given to the issues of diabetes and eyes care along with other essential components like sanitation, environment, water, etc. Celebrations were done at community level focusing on special health issues.

Community Empowerment is not possible without women empowerment. The process of women empowerment was started by building up knowhow level of the women by way of group and individual interactions. They were made aware of their legal rights and also provided with support and counseling at their door steps.

They were enabled to enhance their spending power by establishing regular source of income. They were helped to establish production units and working units and also helped to find profitable jobs suitable to their technical skills acquired at the organization.

They were guided to access the benefits available with the government sources. Delhi Swavlamban Yojna and Pradhan Mantri Jan Dhan Yojna are some of the examples of the same. User rate of these schemes has increased tremendously. The women in one of the areas were helped to procure Food and Supply License as well.

Now the women are on the path of development. The empowered women can empower their families and the community at large. About 2000 women were enabled to empower themselves with additional knowledge and skill and also financial assistance in some cases.

Sultana overcomes her conservative background

Sultana resides at Khureji Khas. Hailing from a strongly traditional Muslim family, she was never allowed her to go to school, especially by her grandfather. Sultana was married off at the young age of 15 to a man 35 years old, who also hailed from an equally conservative family. He forbade Sultana from getting out of the house and mixing with others. Rasta staff, during one of their community visits to the area, came in contact with her and heard her story. Sultana told them of her desire to study. Rasta staff enrolled her in the Rasta Adult Education Centre and prepared her for the Class X Examination of NIOS, which she passed creditably. She is presently working as Supervisor at Herbal Life on a monthly salary of Rs.5000/-.
