It gives me immense pride to share Rasta's journey and achievements in the year 2024–25, a year guided by the national vision of Viksit Bharat. Staying true to our commitment of aligning all our programs with government systems and the Sustainable Development Goals (SDGs), we continued to work towards building an inclusive, empowered, and literate society. In education, we enrolled more than 1,500 children in Non-Formal Education programs and successfully mainstreamed over 250 of them into formal schools. Our literacy initiatives expanded to villages in Uttar Pradesh, furthering our reach and impact. In line with the national aspiration of eliminating illiteracy during India's Amrit Kaal, we continued adult literacy program in Bulandshahr district, enabling over 10,000 individuals to read and write for the very first time. Our livelihood and skill development efforts created opportunities for 48 individuals to become entrepreneur, equipping them with the skills and training required to earn a sustainable livelihood. In the health sector, we reached more than 25,000 individuals with awareness on HIV/AIDS and other critical health issues, strengthening community well-being. This year also marked a significant milestone—Rasta's 30th Foundation Year. To celebrate, we published a book showcasing the inspiring journeys of 30 achievers whose lives were transformed through Rasta's interventions. These stories are a true testament to the power of collective action and resilience. We are equally proud to have successfully integrated many of our beneficiaries into key government schemes, ensuring lasting benefits for marginalized individuals and communities. With limited resources but a deeply committed team, Rasta has consistently delivered meaningful and measurable outcomes. On behalf of the organization, I extend my heartfelt gratitude to our stakeholders, donors, sponsors, supporters, volunteers, and the dedicated Rasta team. Your unwavering support has made this journey possible. As we look ahead, we remain optimistic about expanding our resources and scaling our impact, with the shared vision of contributing to a Viksit Bharat—a developed, inclusive, and equitable India.

Together, we will continue to make a lasting difference in the lives of those who need it most.

# About

Rasta is a Non-Government Organization, functioning since 1994 for the empowerment of the vulnerable sections of the society in Delhi, Uttar Pradesh, Uttarakhand and Haryana, and enjoying national jurisdiction. Our main areas of intervention are Education, Community Health, Women Empowerment and Skill Development.

So far, we have educated more than 30,000 children, of whom 10,000 have been mainstreamed into formal schools. We have developed our own, need based, teaching learning material in Hindi, Maths and English for classes 3rd and 4th and imparted vocational skills to over 1300 youth out of whom a good number have secured jobs. Rasta has also conducted research studies for National and International Organizations.

We have provided health benefits to more than 4,00,000 people and helped approx. 50,000 women under Women Empowerment Programmes. Rasta is presently impacting the lives of more than 5,00,000 people directly and 15,00,000 people indirectly.

# Rasta School



With the sole objective of promoting education for girl children, Rasta initially began its work in Khora Colony, Ghaziabad, by setting up a Non-Formal Education Centre. Until 2015, these centres were the primary mode of reaching out to underserved children. In 2015, a significant milestone was achieved when RASTA School received official recognition from the Government of Uttar Pradesh to operate classes from Nursery to Grade 8. The school is strategically located near NH 24, NH 9, and the Meerut Expressway, making it accessible to the surrounding communities. Since its establishment, the school has provided education to approximately 2,200 children, including 304 students in the academic year 2024–25.



# Highlights

304 underprivileged children (Nursery to Class VIII) were provided quality education.

- Regular academic support and personalized attention led to strong parent–teacher engagement, helping prevent dropouts.
- A total of 16 co-curricular and enrichment activities were conducted to promote holistic development, including:
  - Science Exhibition with 62 student participants and 18 model displays.
  - Educational tour to the Taj Mahal.
  - Celebrations of national events: Independence Day and Republic Day.
  - Observance of key days such as Earth Day, Hindi Diwas, Children Day, Annual Sports Day, Teacher’s Day, International Literacy Day, and National Girl Child Day.
- Rasta students won accolades in external competitions, 2nd prize at National Museum’s Bhashan Pratiyogita.
- Annual academic assessment showed:
  - 34 students scored in the A1 band (91–100%) and 73 students in the A2 band (81–90%).
  - Majority of students performed between 51%–90%, indicating strong academic outcomes.
- Strong emphasis on moral values, teamwork, and communication skills through regular skits, speeches, and assemblies.
  - Classroom environment was enriched through decoration, student-led events, and active participation in cultural programs.



# **Success Story**

**From crisis to courage — Humera continues her education with strength and support, proving that hope can overcome hardship.**



**Humera, born on 17/07/2014, joined Rasta School in 2021 in Class 2 and currently studies in Class 5.**

**She is a quiet, respectful, and sincere student who participates actively in both academic and extracurricular activities. She has three sisters, all of them are enrolled in Rasta School, indicating the family's strong value for education. Initially, the family was sustained by her father, who sold homeopathic medicines.**

**However, after being diagnosed with cancer, he became bedridden and unable to work. This sudden loss of income placed the family in severe financial crisis, and he considered discontinuing his daughters' education due to the inability to afford schooling costs.**

**At this critical point, Rasta School intervened, assuring the family that the education of their daughters would be supported and continue uninterrupted. The school not only extended educational support, but also encouraged Humera's mother, Mrs. Zainab Malik—an educated woman restricted by conservative family norms—to use her skills from home. As a result, she began providing home tuitions, allowing her to earn a modest income while staying within cultural boundaries.**

**Humera continues to excel in her studies and expresses a desire to complete her education and secure a job in the future to support her family. The family remains deeply grateful to Rasta School for its timely support, which preserved the daughters' educational journey and helped the family regain hope and stability.**

# Project Naya Savera, Indira Camp

Project Naya Savera, a collaborative initiative between Rasta and IC Trust, was launched in 1999 and is based in Indira Camp (a JJ Cluster) in Hasanpur near Madhu Vihar, East Delhi. The project focuses on providing quality education to underserved children in the community. In the year 2024–25 alone, Rasta educated 214 children under this initiative, bringing the total number of beneficiaries to over 2,300 since the project's inception. A majority of these children have been successfully mainstreamed into nearby government schools. To support their continued academic journey, Rasta also conducts evening remedial classes, helping students strengthen their learning and keep pace with the formal school curriculum—thus minimizing the risk of dropout.



# Highlights

## Program Achievements – Indira Camp Part I & II

- 214 children (26 Preschool + 188 REC) from underprivileged backgrounds were enrolled and provided quality education and foundational learning support.
- 37 out-of-school children were successfully mainstreamed into age-appropriate classes in Government Schools.
- Learning gaps were addressed through regular assessments and remedial classes for weaker students.
- 36 Parent-Teacher Meetings (PTMs) were held, with participation of 399 parents, fostering strong school-home collaboration.
- 335 home visits were conducted to ensure student retention, identify challenges, and provide necessary support.
- A series of co-curricular and cultural activities were conducted to promote holistic development:  
Day, Independence Day, Raksha Bandhan, Janmashtami, Diwali, Christmas, Republic Day, Basant Panchami, and Holi celebrated with active student participation.  
Visit to Rajiv Gandhi Foundation (twice) with 66 children for exposure to environmental and educational activities.
- Significant reduction in school dropout rates, both at government schools and Rasta learning centres.
- Continuous teacher engagement with parents and government school staff helped ensure regular attendance and academic progress.



# Project Shiksha Plus, Bulandshahr

Rasta, in collaboration with the Shiv Nadar Foundation, is working towards eradicating illiteracy in the Sikandrabad and Block of Bulandshahr District, Uttar Pradesh through the SHIKSHA Initiative. The program aims to foster lifelong learning by enhancing educational outcomes through a technology-enabled approach. Building on this mission, the initiative has expanded its focus to include adult literacy under the banner of Shiksha Plus. This component uses an ICT-based methodology to teach foundational skills in reading, writing, and arithmetic to illiterate adults, ensuring that learning becomes accessible and impactful across all age groups.



## Highlights

During the period, 10013 adults- 9444 women and 569 men- from Khurja and Sikandrabad block of Bulandshahr district, were enrolled and educated;

2 certificate distribution ceremonies were organised in which 6000 learners were awarded certificates, by the representatives of Shiv Nadar Foundation;

- i. To identify the Jan Shikshaks 3 pre-selection trainings were organized and after the selection, 3 orientation trainings were organized; the process involves conducting survey in 68 villages of 2 Blocks, comparing the findings with census data.
- ii. Proper monitoring was done at village level. These included management visits, monthly and quarterly reviews by concerned project staff;

Other activities like eye-checkup camps, training on PoSH (Prevention of Sexual Harassment at Work Place) Act, training on MHM etc. were also organized




# Success Story

## Vineeta's Journey of Transformation: From Adversity to Empowerment

Vineeta, a 27-year-old resident of Siryal village in Khurja Block, Bulandshahr District, faced a life-altering incident in her childhood. While cutting grass, she tragically lost her left hand. This not only affected her physically but also became a barrier to her education. Her parents, discouraged by her condition, chose not to send her to school. Although Vineeta dreamt of being educated, she found no support for her aspirations.

Years later, she got married to Dinesh, a man who also had a disability, as he was born with only one hand. Due to his condition, Dinesh struggled to find stable work, leaving the family in financial hardship. Despite these challenges, Vineeta remained determined to provide quality education for her two children. However, their limited income made it difficult to achieve this goal. One day, during a survey for the Shiksha Plus Adult Literacy Program, volunteer Ms. Karuna met Vineeta and introduced her to the initiative. Ms. Karuna emphasized that education has no age limit and explained how the program could help her support her family in various ways. Motivated by this conversation, Vineeta decided to join the program and began attending literacy classes. In just four months, Vineeta learned to read and perform basic math. She now helps her children with their studies, ensuring they get the support she once lacked. Encouraged by her progress, Vineeta aims to join a Self-Help Group (SHG) in her village to start a small business, contributing to the family income and securing her children's education. Her husband, Dinesh, stood by her side throughout this journey. With his unwavering support, Vineeta transformed her life, proving that with determination and opportunity, one can overcome any obstacle and build a brighter future.



# Project Uday

Project UDAY, supported by the HCL Foundation, is a continuation of the initiative launched in 2016. The project addresses the educational needs of migrant children by providing non-formal education and supporting their transition into mainstream schools. In addition to academic learning, Rasta also promotes essential practices related to social security schemes.

Under Project UDAY, learning is structured into five key categories:

1. Pre-School Education (3–6 years): Early childhood learning to prepare children for formal schooling.
2. Non-Formal Education (6–14 years): Basic education for out-of-school children to bridge learning gaps.
3. Remedial Education: Academic support for children already enrolled in formal schools to strengthen their foundation.
4. NIOS (Open Basic Education): For children who could not be mainstreamed, age-appropriate learning is provided through the NIOS curriculum, preparing them for OBE certification for Classes 3rd, 5th, and 8th.
5. Evening Computer Classes: Digital literacy classes for both children and adults from the community.



# Highlights

## Key Achievements – Project UDAY

- 1,498 children enrolled in ECCE, Bridge, OBE, and REC programs.
- 252 children were successfully mainstreamed into formal government schools.
- 28 students were registered for OBE under NIOS; 24 appeared for final exams.
- 209 students attended evening REC and computer classes; 63 received computer course certificates.
- 571 individuals were linked to social security schemes, including:
  - 115 Aadhaar cards made, 92 birth certificates, 41 Sukanya Samriddhi Yojana accounts, and 185 Ayushman Bharat Cards generated.
- Two health camps benefited 472 learners with eye, ear, and dental check-ups and free medicines.
- 30 community meetings held; 335 home visits conducted to reduce absenteeism and ensure parent engagement.
- 11 monthly assessments conducted to track learning levels and prepare children for mainstreaming.
- 5 capacity-building trainings conducted for teachers on TLM, child protection, HIV/AIDS awareness, effective teaching techniques, and more.
- Staff meetings held monthly, ensuring regular review, planning, and improved program delivery.
- Extensive community mobilization and awareness campaigns on health, hygiene, documentation, and government schemes.
- Celebrated over 25 cultural events and national days including: National Girl Child Day, Annual Day, Environment Day, Yoga Day etc.



# Success Story

## Case 1

Sadhna's family has been living in Sambhal block for the last two years. There are 5 people in the family. Her father works as a laborer and her mother takes care of household work. They came here from their village Bilvai in search of better opportunities.

Sadhna's family lives in a small rented house with her family. Her mother shared that her children were not going to school. We visited her home and saw that there were many other children in the neighbourhood who also were not studying. Some parents were willing to send their children to school, but they didn't have Aadhaar cards, which are needed for school admission. Sadhna's mother said that she tried applying for Aadhaar cards, but failed because they don't have proper documents. She went many times but couldn't succeed. Then we took her and the children to the Aadhaar center. The first time, it didn't work because she didn't have documents. The second time, she managed to get one child's Aadhaar made, and on the third visit, we helped to get Aadhaar cards for all three children. We then enrolled the children in our center. She was very happy and thankful to HCLF Rasta Gurukul for helping her.



## Case 2

Diksha lives with her parents and younger brother. Her father works as a guard and her mother works as a maid in a society.

When our team was doing a survey, we met Diksha and found out that she had taken admission but didn't have an Aadhaar card. Her school needed the Aadhaar. Her family had applied online, but after a week, they didn't receive any update. They were told Aadhaar hadn't come yet. Our team advised her father to visit the Aadhaar office, but due to lack of time and knowledge, he couldn't go. After 10-12 days, they went and found someone else's Aadhaar with their name. The Aadhaar had wrong details.

We helped them understand the process and gave them correct information. Later, her father updated all documents and also opened an account for Diksha under Sukanya Samriddhi Yojana.




# Targeted Intervention

With the support of NACO and DSACS, Rasta is reaching out to migrant workers through its Targeted Intervention Project—bringing vital knowledge about HIV/AIDS right to their communities. Whether it's through a health camp, an awareness event, or a powerful street play, the message is clear: awareness saves lives. By working directly in areas that need it most, Rasta ensures that education and prevention go hand-in-hand.

## Highlights

- 20,052 migrant workers were registered under the program.
- 5,275 one-to-group awareness sessions were conducted.
- 83,159 migrant individuals were covered through IPC sessions.
- 300 health camps were organized for migrant communities.
- 8,815 migrants participated in health camps and project clinics.
- 21,840 condoms were distributed/sold as part of the safe sex promotion initiative.
- 2,736 migrant individuals were tested for HIV (via ICTC and CBS).
- 24 advocacy meetings were conducted to engage stakeholders and influencers.
- 16 large-scale congregation events were held to raise awareness.
- 48 demand generation activities were organized to improve service uptake.
- 36 street theatre performances were conducted to disseminate key health messages.
- World AIDS Day was celebrated with a candle march



# Success Story

One case, many lessons — the power of counselling, patience, and persistent outreach.”

During the health camp organized by our organization, a person (name changed for confidentiality) named Suraj was found to be HIV-positive. When the counselor informed him about this and advised him to visit the concerned hospital for further testing, Suraj refused to undergo the confirmatory test and left.

After a few days, the counselor contacted Suraj again, but he again declined to get tested. The counselor tried to convince him, but Suraj repeatedly refused.

The counselor attempted many phone calls, but Suraj changed his number. A home visit was conducted where the counselor met Suraj's wife and their two children. The counselor provided them guidance on HIV prevention, the importance of using condoms, and family planning methods.


Suraj's wife was counseled separately and she agreed to accompany her husband for medical testing. Her contact number was taken for follow-up.

When no response was received for several days, the Project Manager personally visited Suraj's home and met him.

Both Suraj and his wife were informed about the risks related to STIs and TB, the importance of timely treatment, and protecting their family.

The next day, Suraj, his wife, and their children underwent testing, and fortunately, then his wife and children found to be HIV-negative/safe.

However, Suraj's health condition had deteriorated. Due to proper medication his mental and physical condition has improved, and get capable to do work.



# Project WelNetrutva



Project Welnetrutva is an extension of the 2022 project which was running in Gyaspur and Nehru camp community of east Delhi. This initiative of Welspun Foundation focuses on the livelihood and health of the adolescents, women through life-skills sessions, health camps, etc. Currently, this project is being run in Debai and Danpur Blocks, Bulandshahr district with an aim of providing preventive healthcare services and livelihood to 2000 beneficiaries. Through this project, Anaemia testing, capacity building of staff, making health groups, IEC material, BCC sessions, Livelihood meetings and mega stakeholder meeting are to be conducted and linking of families with Social Security Schemes

## Highlights

- i. The intervention started in the block of Debai and Danpur of Bulandshahr district. 5 villages namely Govindpur, Edalpur, Sherpur, Jaraina, Udaipur kala.
- ii. Line listing of 2,088 beneficiaries along with 2,000 women went through Anemia screening.
- iii. 4 capacity building trainings were organized for the staff.
- iv. Prepared IEC material flipbooks for BCC sessions on topics like: MHM, Anemia & Nutrition, RTI/STI, Cervical and Breast Cancer.
- v. Formed 80 health groups of people and conducted 40 BCC sessions on MHM, conducted 18 Livelihood Meetings in these villages.
- vi. Linked 136 families to Social Security Schemes like Ayushman Bharat, PM Vishwakarma, PM Kisan Samman Nidhi, Old Age Pension, Disability Pension & PM Saur Ghar.
- vii. Prepared 48 entrepreneurs who have established their enterprises and now earning well.




# Success Story

In Govindpur, women from Self Help Groups, including Hajara and Fareeda, began a journey toward financial independence with support from Rasta. After discussions and training under the Entrepreneurship Development Program (EDP), they identified sanitary napkin production as a suitable business idea to meet local demand and improve women's health.

With a detailed business plan, they secured a Cash Credit Loan (CCL) from a bank after approaching the BDO, BM, and ADO. The group also visited a Delhi-based company and partnered with DR Enterprise to learn about production, packaging, and sales. This training and exposure enhanced their skills in business management and marketing.

Rasta and the Welspun Foundation provided continuous support through financial literacy sessions, mentoring, and guidance, helping ensure the sustainability of their enterprise.

Today, the women run a successful sanitary napkin business that not only provides them steady income but also promotes menstrual hygiene in the community. Their achievement stands as an inspiring example of how training, financial access, and collaboration can empower rural women and drive community development.



# Mahila Panchayat

Rasta runs Mahila Panchayat Programme in Mandawali area, Delhi with the support of Delhi Commission for Women (DCW). Objectives of this programme are:

- To create mass awareness among women.
- To make them legally aware and empower women for their legal rights,

It provides a conflict resolution forum relating to family disputes at the community level and prepare them for legal actions to seek legal aid as and when required. These cases mainly pertain to Bigamy, Maintenance, Domestic Violence, Alcoholism and other issues. Apart from this, service-related cases for securing Aadhar Cards, Voter ID Card, Birth Certificates, etc. have also been addressed.

## Highlights

- During the year, the team registered total 471 cases and solved 227 cases besides 31 cases given by DCW.
- To make aware community women about the objectives of Mahila Panchayat and Domestic Violence act, 53 Mahila panchayat meetings and 53 community meetings were organized stating the facts of Domestic Violence Act.
- The team carried out 786 door-to-door visits to do follow-up of cases registered and given by DCW.



# Success Story.

**“When misunderstanding was turning into separation, counselling became the bridge back to harmony.”**

Saida came to our office through a volunteer and shared problems in her marriage with Mujahid. They had married two years ago and initially lived happily, but six months earlier Mujahid began avoiding her and expressed that he no longer wanted to stay with her and wished to marry someone else.

We called both for counseling. Mujahid revealed that he was under 18 at the time of marriage and that they had agreed to keep the marriage secret—but when he found out that people in the community knew, he withdrew emotionally.

We counseled both, discussed consequences of breaking vs continuing the relationship, and gave Mujahid time to think. Later, Saida reported that they were living together again but she feared he would not return from his hometown visit. We called them again, spoke to Mujahid and his uncle, and received assurance that he would return soon.

Throughout the period, we did follow-ups, and they stayed in communication. Mujahid returned to Delhi, and the couple came to the office looking happy and united. They signed a Raaji naama agreeing to live together and keep their marriage confidential. After three follow-ups, they continue to live happily and thanked our team for saving their marriage, saying that without our support, they might have pursued divorce.



# Major Activities of the Year



## 30<sup>th</sup> Foundation Day of Rasta

This year Rasta celebrated its 30<sup>th</sup> foundation along with National Girl Child Day on 24<sup>th</sup> January 2025. The occasion was graced by eminent dignitaries, including Shri Murli Manohar Joshi, former Minister of Human Resource Development, Government of India, as the Chief Guest. Dr. Nidhi Pundhir, Global Head of CSR at HCLTech and Director of HCL Foundation, and Shri Vinod Agnihotri, Consulting Editor of Amar Ujala, attended as Guests of Honour. The distinguished guests launched Rasta's commemorative book, "Hamara Safar 30-30", chronicling three decades of impactful work. They also presented mementos to Rasta's supporting partners and celebrated the achievements of program participants, applauding the inspiring cultural performances.

## Collaboration with Zomato Feeding India

Rasta collaborated with Zomato Feeding India to provide cooked meals to our children. Many of our children are vulnerable to malnutrition because of lack of nutritious food. We are continuously in touch with the parents of these children. Through this initiative over 273 beneficiaries were provided with freshly cooked meals.

## STEM lab at Rasta School

Smile Foundation installed STEM Lab at Rasta School. This initiative aimed to create more engaging and practical learning environment.

## Amani Project

Rasta collaborated with Smile Foundation for Amani Project under which 2 music classes used to be conducted in every month, to foster creativity and teamwork through the medium of music.

## Collaboration with Lenskart Foundation

Rasta collaborated with Lenskart Foundation to organise eye check – up camps helping in Bulandshahr and benefited over 1080 beneficiaries, those in need of spectacles were provided to them on spot.

## Collaboration with DCWA

We collaborated with Delhi Commonwealth Women's Association (DCWA) to conduct health camps in Noida. They conducted 2 big health camps in Sarfabad and Mamura. The total number of 472 participants received general health check – up, free medicines were provided to all individual requiring treatment. This provided the community a basic health checkup and medicine that they usually don't get by themselves.







## Workshop by National School of Drama (NSD)


We collaborated with National School of Drama. They selected 35 children from our centre gave one month long training where the children prepared a play. After one month of rigorous training, children got a chance to perform at NSD campus, Delhi. It was a proud moment for children as well for us that the children who never been to school and belong to a marginalized community got a chance to perform on such a high platform. Children performed very well and received appreciation prizes by renowned film star and NSD faculty.

## Integration of Goonjan Application

We are living in an era driven by digital infrastructure, where everything and everyone is increasingly connected through technology. In today's world, data holds immense value, and digital tools have made its collection, storage, and analysis more efficient than ever before. At Rasta, we proudly align ourselves with the Digital India Mission, embracing technology to enhance transparency, efficiency, and impact across our initiatives. In the past year, we took several steps toward digital transformation—beginning with the introduction of digital attendance systems for our staff. Building on this progress, we have now adopted “Goonjan”, a software developed by the Dhvani Foundation, to digitize the databases of our various projects. Through this platform, we will capture and maintain comprehensive beneficiary information online, including demographic details, essential documents, attendance records, and assessment data. This digital transition will enable us to access real-time project insights, strengthen data-driven decision-making, and effectively monitor progress—ensuring that our efforts continue to make a measurable and meaningful difference in the lives of our beneficiaries.

## Participation in Vedanta Delhi Half Marathon

Rasta participated in Vedanta Delhi Half Marathon as a NGO partner. Our cause of partnering with VDHM was promoting Girl child education. We run for this cause and this our firm objective since the inception of Rasta. The marathon was organized in 2 mode- physical and online. Our team participated in both the modes. Our management team, CEO, CMO and extended project team went to Jawahar Lal Nehru Stadium and completed the marathon giving our sweat and received our medals. We generated funds to support our Girl child based programs.
